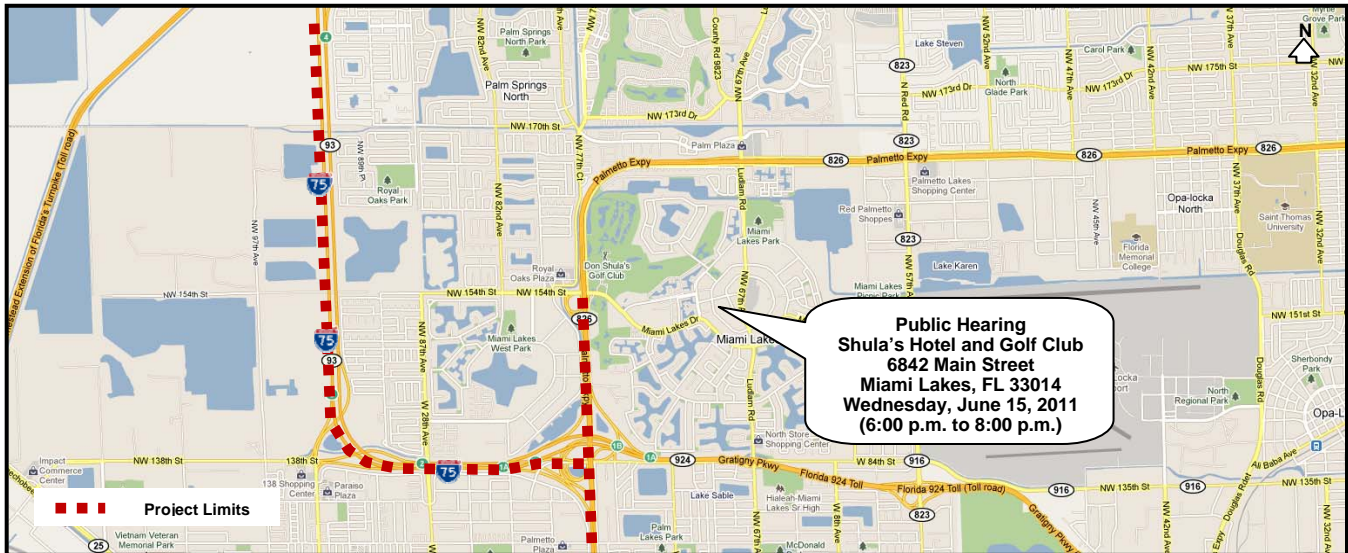


PUBLIC HEARING NOTICE

**I-75/SR-93 Project Development & Environment (PD&E) Study
From State Road 826 (SR-826)/Palmetto Expressway to
North of the Miami-Dade/Broward County Line

The Florida Department of Transportation (FDOT), District 6, will conduct a public hearing for the proposed improvements to I-75/SR-93 in Miami-Dade County, Florida, Financial Project Number 420669-1-22-01. The hearing will be held on June 15, 2011, from 6:00 p.m. to 8:00 p.m., at Shula's Hotel and Golf Club, Grand Slam Ballroom, 6842 Main Street, Miami Lakes, Florida 33014. The hearing will begin with an open-house at 6:00 p.m. followed by a formal presentation at 6:30 p.m. The proposed improvements involve the I-75 PD&E Study from State Road 826/Palmetto Expressway to North of the Miami-Dade/Broward County Line, for a distance of approximately 9 miles.



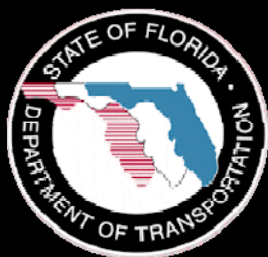
This public hearing is being conducted to give interested persons an opportunity to express their views concerning the location, conceptual design, and social, economic, and environmental effects of the proposed improvements and in accordance with Federal Executive Orders 11990 and 11988. The proposed improvements consist of adding express lanes in each direction within the median, increasing interchange capacity and operational enhancements including auxiliary lanes to provide better access to the interstate.

The draft project documents and other information will be available for public review from Wednesday, May 25, 2011 to Wednesday, June 15, 2011 on weekdays only, excluding major holidays, at the following locations: FDOT, 1000 N.W. 111th Avenue, Room 6111A, Miami, FL 33172, from 8:00 a.m. to 5:00 p.m., and the Town of Miami Lakes, Town Clerk's Office, 15150 NW 79 Court, Miami Lakes, FL 33016, from 8:30 a.m. to 5:00 p.m. Persons wishing to submit written statements or other exhibits, in place of or in addition to oral statements, may do so at the hearing or by sending them to: Mr. Dat Huynh, P.E., District Project Development Engineer, at FDOT, 1000 N.W. 111th Avenue, Room 6111A, Miami, FL 33172. All exhibits or statements postmarked on or before June 27, 2011 will become a part of the public hearing record.

FDOT District 4 will conduct an additional public hearing on Tuesday, June 14, 2011, from 5:30 p.m. to 7:30 p.m., at the Broward County Southwest Regional Library, 16835 Sheridan Street in Pembroke Pines to focus on the improvements in Broward County. The hearing will begin with an open-house at 5:30 p.m. followed by a formal presentation at 6:00 p.m.
